(C) No.116 of 1998 in the matter of Justice Sunanda Bhandare Foundation Vs Union of India & Ors, all Departments are hereby requested to strictly adhere as per the Act and issue necessary orders/notification/OM in compliance with the relevant provisions/sections of the Act pertaining to their respective departments within 15 (fifteen) days from the issue of this OM.

2. It may be borne in mind that non compliance of the Act/Judgment by the departments, the Government of Nagaland will be liable for punitive action.

3. This supersede all the earlier orders/notifications/OM issued under the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995.
